

# **From SFA Headquarters**

#### SPECIAL FORCES ASSOCIATION POLICY OR PRECEDENT

SUBJECT: Membership Dues & Chapter Rebates

DATE: 31 August 2016

POLICY NUMBER ORIGINATING SECTION ORIGINATOR SFA -03

APPROVED: Gary Koenitzer, President

APPROVED: Jim Blanchard, Secretary

PURPOSE: To establish the Special Forces Association policy for dues and dues rebates to Chapters.

SCOPE: This policy applies to dues for all members within the Special Forces Association and is governed by Article IV, Section Dues and Fees, of the current Special Forces Constitution.

#### ANNUAL MEMBER DUES:

Dues for any calendar year cover the period from 1 January through 31 December, regardless of the date dues are actually paid. Dues received between 1 October and 31 December are applied to the next year's dues. (i.e. dues paid between 1 October and 31 December of each year will be credited to the next year's dues). Dues received prior to 1 October are processed for and apply to the current fiscal year.

Article IV, Section Paragraph A, of the Special Forces Association Constitution states members who have not paid their dues within 30 days after 31 December (30 January) become lapsed members. Lapsed members will incur a reinstatement fee of \$5.00.

Chapters must insure eligibility of new members as outlined on the application. Chapters must submit appropriate documentation as required. When submitting dues for multiple members please combine and remit on one check with a cover letter detailing member name, member number and any information changes.

Dues received after 1 October will be credited for the following year. The grace period will extend until January 30. If dues are not received by then a member will revert to Inactive status and be required to reinstate.

Applications and renewal/reinstatement forms are in the DROP or can be obtained from National or the Special Forces Association website. These forms may be reproduced for Chapter use.

Members At Large remit dues directly to National Headquarters. No portion of At Large Member dues are shared with the Chapters.


