### **MESSAGE FROM THE PRESIDENT**

I have been out of the AO for a while due to personal reasons and SF events and it's good to be back. Our board meeting on October 8th was well attended and pertinent infomation was discussed. We also commemorated chapter member Ramon Gaytan's "million dollar combat wound that allowed him to be evacuated from Viet-Nam in 1968. Ray set up the bar for several rounds of libations; thanks bud!

Chapter member and acting Quatermanster for VFW Post 8541 Adan Flores, briefed us on the financial difficulties of the VFW Post. He stated that the Post is in arrears for thousands of dollars and the possibility exists that it may be forced to cease operations. Although we have heard similar reports in the past, this sounds more substantial and it presents a situation where we may have to look for another venue in which to hold our meetings and other chapter functions. For certain, we will be renting a storage space and transfer all our chapter belongings next week. We were actually going to rent a space before Convention 2013 so this situation with the post just gives us an impetus to do so now. I will of course keep you apprised of all changes as they occur.

On another note, for some time now, a few chapter members have been discussing the idea of procuring a permanent "safe house" for our chapter. This will entail finding a suitable parcel of land and build a pre-fab building, or purchase a double wide mobile home in which we can display our chapter artifacts and hold other chapter functions. If anyone knows of a plot of land that may be availble, please contact CSM Bill Smith, The Godfather, Mike Maloy or Smitty. These members compose the Ad Hoc committee involved in this venture. 




