#### **Chapter Motorcycle Challenge**

#### Warriors on the Way



Steve Rindahl, a Chapter XV member and retired Army chaplain, is organizing a pilgrimage for a dozen combat veterans to walk the Camino de Santiago (Way of St. James) in Spain next year. "Warriors on the Way," a 180-mile trek along the famous trail in northern Spain, will run from Sept. 14 to Sept. 30, 2018.

After 15 years of U.S. involvement in the conflicts in Iraq and Afghanistan, Steve says the levels of PTSD and "moral injury" among veterans are rising rapidly. Outdoor activity, especially hiking, is well known to help with processing wartime experiences, he says. And research shows that intentional spiritual practices can reduce tension, depression, anger, fatigue and confusion (all commonly found in those diagnosed with PTSD.) Steve also notes that a pilgrimage ties in with the "ruck march" experience common to all veterans.

Warriors on the Way will capitalize on this unique dynamic "which allows for time to oneself while always being part of the larger team," he says.

Steve is an experienced pilgrim, having made several pilgrimages based on veteran healing. He served 15 months as a chaplain in Iraq. He has used these experiences, plus what he learned completing his doctorate in responding to combat



trauma, to design the 2018 trip.

Steve is seeking support for the pilgrimage in two ways. First, if you know a veteran diagnosed with PTSD who may benefit from this program, please refer him to Steve. Second, he hopes to raise \$45,000 to finance the complete trip (transportation, food, equipment, lodging) for 12 veterans to be selected.

"Whether you can send enough to cover the cost of a single meal or the \$3,750 that it will take to fully sponsor one veteran -- or anywhere in between -- you can make a difference," he says. Tax-deductible donations can be made to SSA Memorial and marked to support the Veterans Pilgrimage.

MSG (R) Daniel James Kling, 83, passed away quietly on September 12, 2017 with all of his family at his side in Plano, Texas.

Very early in his life he joined the Army and found himself on the battlefield in Korea, assigned to the 45 Infantry Division. Upon his return home, he was assigned to the 7<sup>th</sup> Cavalry and stationed in Japan. Shortly after, he volunteered for the Special Forces where, upon completion of some rigorous training was assigned to the 5<sup>th</sup> Special Forces Group at Ft. Bragg, NC.

He served several tours in Vietnam where he was awarded 2 Bronze Stars, The Purple Heart, Silver Star, Combat Infantry Badge (2<sup>nd</sup> Award) and various other awards. He retired in 1975 after serving in the Army for 28 years.

Upon separation from the Army, went on to become a successful salesman predominantly in the telecommunications Industry. He was a Life Member of the Special Forces Association (D-392) and active member of the San Antonio Special Forces Chapter XV. He feared God, loved his County and adored his Family.

He is survived by his wife MaElena, son Armando and his wife Nayeli, daughter Claudia and husband Jeff, daughter Erica and husband Dustin, daughter Kelly and husband Terry. He is also survived by his grandchildren, Isabel, Natali, Mackenzie, Corbin, Dylan, Lincoln, Olivia and his faithful dog CINCO. His ashes will be buried at the Dallas Fort Worth National Cemetery.



#### **Special Forces Chapter XV Education Grant**

The Special Forces Chapter XV Education Grant is designed to provide a one-time education grant of a minimum of five hundred dollars (\$500.) The number and amount of grants are determined by the Chapter Scholarship Selection Committee with the approval of the Chapter president. Recipients will be announced at the annual Installation of Officers/ Christmas Banquet.

#### Eligibility:

- 1. Applicant must be a SFA member or legal dependent or grandchild of a Chapter member in good standing.
- 2. A high school student anticipating graduation during the school year of application.
- 3. Grant must be used to attend an accredited college, university or vocational institution.
- 4. Eligible applicants must submit the following:
  - A personal letter detailing the applicant's education plans, career aspirations, school they plan to attend, and planned use for the grant.
  - b. Copies of the most recent academic transcripts, SAT scores and other scholastic achievements, and a recent photograph.
  - c. Two letters of reference from a teacher, school counselor or principal.
  - d. A summary of extracurricular activities, non-academic achievements and hobbies.
  - e. A copy of the application to the school or the acceptance letter.
